- In Swindon, Seetec's 'Work and Health Programme Pioneer' is transforming lives by helping economically inactive individuals secure sustainable employment.
- This initiative provides tailored support, including CV building, qualifications, upskilling courses, and interview practice. It aims to break down barriers for long-term unemployed individuals facing significant challenges such as disabilities, health issues, victims of domestic abuse, care leavers, ex-offenders, evacuees, Armed Forces Veterans, and those with drug and alcohol dependencies.
