
- **Partner Feedback:** We are actively improving communication regarding the closure or progression of safeguarding concerns and welcome continued feedback.

Swindon's Early Help Model has a three-pronged approach of Child First, Think Family and Community, providing the widest and most holistic support for children and young people, recognising them as the priority. **Change to language!** A decision has been made to drop the language of the Early Help Assessment to adopt a more inclusive and supportive Early Help Conversation approach.

Early Help Conversations with families ensure that they have access to the right help at the right time to meet need and improve outcomes.

The Early Help Conversation is recorded to consider the needs of a child and their family so that a Family Plan can be developed and implemented to ensure support is in place to meet need and improve outcomes.

## Leaving children home alone – NSPCC Advice

- In the past year, the NSPCC helpline has seen a 65% increase in adult concerns about children being left home alone with 7,802 contacts on the subject of a child being left home alone received between April 2023 and March 2024, compared to 4,717 contacts over the previous 12 months. NSPCC have published a news story about children being left home alone which discusses possible reasons for this increase including greater public awareness around the risks. The news story provides guidance and a link to a quiz to help parents decide whether their child is ready to be left home or go out alone.

### **Prevention of Sudden Unexpected Deaths in Infants** (SUDI)

- Having effective safe sleep conversations with families supports the prevention of sudden unexpected deaths in infants (SUDI).
- Advice and guidance is routinely given to parents by maternity and health visiting staff, however, national and local reviews show that it is every professional's responsibility to promote safer sleep.
- Please familiarise yourself with safe sleeping information and advice to have effective safe sleep conversations with parents and families.
- A BSW SUDI Prevention Policy and Promoting safer sleep for infants' guidance has been developed and will be published soon.
- In the interim please consider how you can incorporate safe sleep messages into your practice. Below are some resources/information to help raise awareness:
- when parents / carers are out of routine in their sleeping arrangements, e.g., unplanned emergency situations, child staying with other relatives/friends, this can increase the risk of SUDI.
