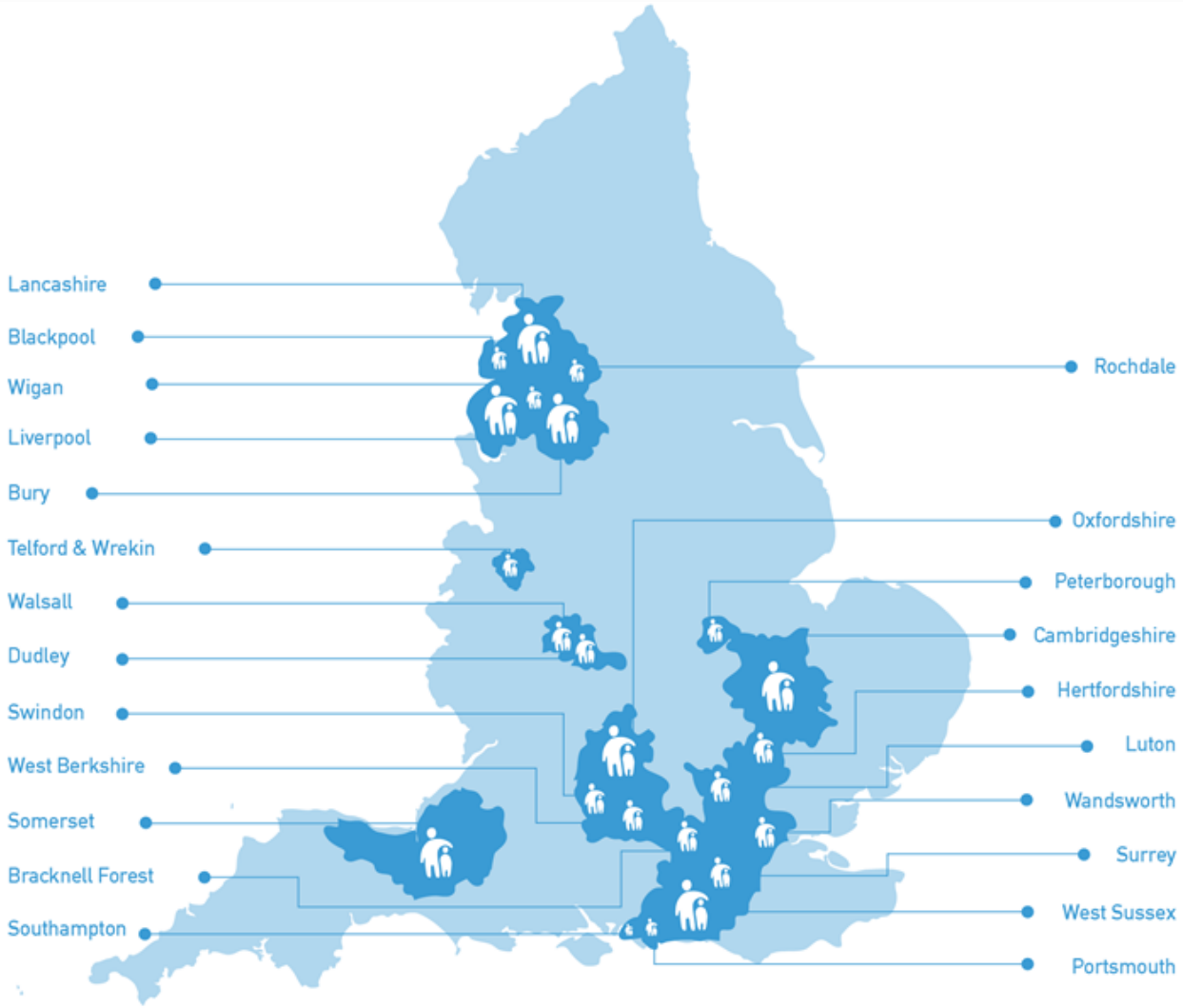


Swindon Children's Services Family Safeguarding Model

- Family Safeguarding was first implemented in Hertfordshire in 2014
- Swindon had their funding approved by Department for Education Strengthening Families, Protecting Children in 2019
- In Swindon, the programme implementation started in May 2021, however the partnership came on board from November 2023 with Probation still to join
- Swindon Children's Services works closely with the Centre of Practice for Family Safeguarding in Hertfordshire alongside the rest of the 26 other local authorities

Family Safeguarding in England

There are currently 27 Local Authorities who have, or are soon to implement Family Safeguarding.

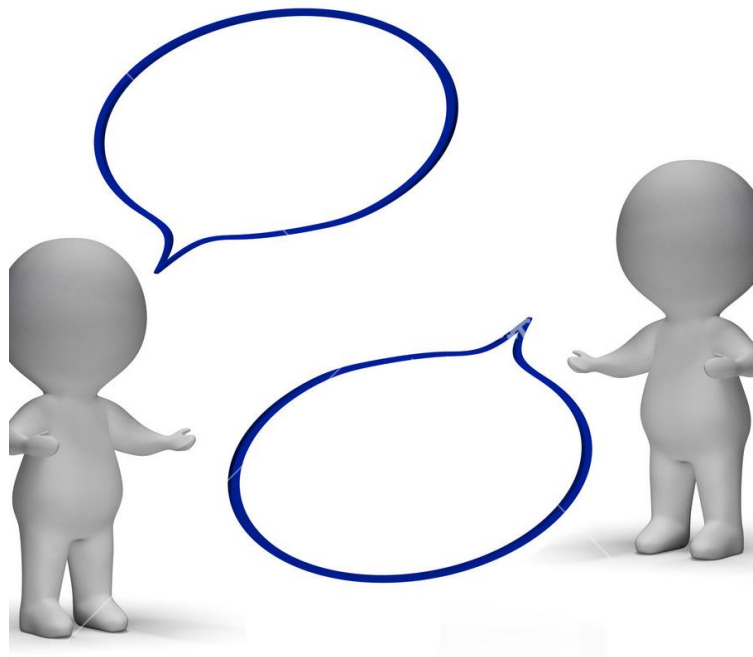
