Child Sexual Abuse Impact on Children

Talking about child sexual abuse and sexual harm can be triggering and can bring up difficult feelings therefore we encourage you to:

Think about your own self Care and what might be coming up for you and how you can look after that

Take a minute out if or when needed

Be kind to yourself

What is CSA?



"IChild sexual abusel involves forcing or enticing a child or young person to take part in sexual activities, not necessarily involving a high level of violence, whether or not the child is aware of what is happening.

The activities may involve physical contact, including assault by penetration (for example, rape or oral sex) or nonpenetrative acts such as masturbation, kissing, rubbing and touching outside of clothing...

Centre Of Expertise - On child sexual abuse

"... They may also include non-contact activities, such as involving children in looking at, or in the production of, sexual images, watching sexual activities, encouraging children to behave in sexually inappropriate ways, or grooming a child in preparation for abuse.

Sexual abuse can take place online, and technology can be used to facilitate offline abuse. Sexual abuse is not solely perpetrated by adult males. Women can also commit acts of sexual abuse, as can other children."



10,500 children seen by sexual assault referral centres (England and Wales)

45,000 children assessed at risk of sexual abuse* (England)

101,000 child sexual abuse offences recorded by the police (England and Wales)

Physical health

Trauma effects the body and can cause a range of physical health problems

Mental Health

Trauma can affect periods of a child's life when their thoughts, feelings and reactions become difficult to manage, impacting their ability to cope

Relationships

Trauma can cause challenges in connecting with other individuals and how they behave . Non abusing parents might struggle to cope with the emotional and practical strain following CSA.

Education

Trauma can manifest as behavioural challenges, emotional dysregulation, and difficulty with learning and focus leading to academic struggle and heightened risk of negative outcomes




How we can support recovery



Swindon & Wiltshire Phoenix Project what we offer

- Stabilization 6/8 sessions
- Psychoeducation
- Counselling up to 24 sessions
- Sand play therapy
- We work to Bluestar Pretrial Therapy Guide to good practice.

If a CYP has concluded their work with the Phoenix project and the court case has still to take place, we will offer additional sessions around that time to support the process and talk over the outcome

Referral Criteria

Be a resident in the Swindon Borough Council or Wiltshire County Council area

Be in a safe and stale place in their own life to allow our therapeutic recovery work to have the maximum impact

No longer be expiring/at risk of further sexual abuse

Not be subject of a current child protection plan at point of referral. However, if child or young person is up stepped to a child protection plan, we will continue with the support to ensure continuity of care

We work with children and YP from 0 to 18 years. If the child is under 5 years we will work with the parent/carer of the infant.

Not be already receiving another specialist, therapeutic support service. This can cause confusion and be detrimental to the healing/recovery process.
